Explanation of Responses:

1. On March 12, 2004, June 1, 2004 and June 1, 2005, NRG Energy, Inc. (the "Company") issued 4,412; 2091; and 1,226 Deferred Stock Units ("DSUs"), respectively, to Mr. Tate under the Company's Long-Term Incentive Plan. Each DSU is equivalent in value to one share of the Company's Common Stock, par value \$0.01. On January 1, 2006, 1,932 of such DSUs (25% (1,103) from the March 12, 2004 grant, 25% (522) from the June 1, 2004 grant and 25% (307) from the June 1, 2005 grant) were exchanged for such Common Stock on a one-to-one basis. Mr. Tate sold the shares in order to cover the tax liability associated with the exchange of DSUs to Common Stock.
