Explanation of Responses:

- Mr. Davido was issued Deferred Stock Units by NRG Energy, Inc. under NRG Energy, Inc.'s Long Term Incentive Plan on March 14, 2005. Each Deferred Stock Unit was equivalent in value to one share of NRG Energy, Inc.'s Common Stock, par value \$0.01. On March 14, 2005, Mr. Davido received from NRG Energy, Inc. one such share of Common Stock in exchange for each Deferred Stock Unit he was issued on that same date. Mr. Davido no longer holds any Deferred Stock Units.
- Pursuant to the NRG Energy, Inc.'s Long Term Incentive Plan, Mr. Davido elected to satisfy his tax withholding obligation upon the exchange of common stock for Deferred Stock Units by surrendering a number of shares of common stock having a value on the date of the exchange equal to the tax withholding obligation.
- This Form 4 is being amended to reflect the surrender of common shares to satisfy the grantee's tax withholding obligation.
